1. Call to Order.

Chair Keefe called the meeting to order at 7:53pm immediately following Joint Review.

2. Approval of TMGAC Minutes.

Minutes from January 15, 2026, TMGAC meeting were presented. A motion was made by Jones-Peretto to approve the minutes as presented and was seconded by Dalton. The motion was approved unanimously.

3. Election of Officers for 2026

Officers are typically elected at the second TMGAC meeting of the year, and current Chair Elyse Keefe and Vice-Chair Jordan Dalton were both eligible for reelection. Jones-Peretto nominated both for a second term, was seconded by Salvesen, and both were reelected unanimously.

4. Discussion Items

a. 603 W NC 54 Review – The Joint Review discussion of 603 W NC 54 continued with Mushegian and other board members asking if it would be possible to have pathways from the proposed gym to the adjoining residential neighborhood off Hatch Rd or to ask for the completion of a sidewalk (or at least the set-aside of a sidewalk easement) on both this property and the adjoining former gas station that is also for sale.

b. Priority Focus for 2026 – Chair Keefe continued a discussion of priorities for the Board in 2026 that began at the January 15 meeting. Topics identified by the TMGAC in the discussion included trails/greenways safety, maintenance of bike lanes with the bike lane sweeper that Eversole-Robinson informed the committee that the town now owns, slowing the statutory speed limit in the town to 20mph,

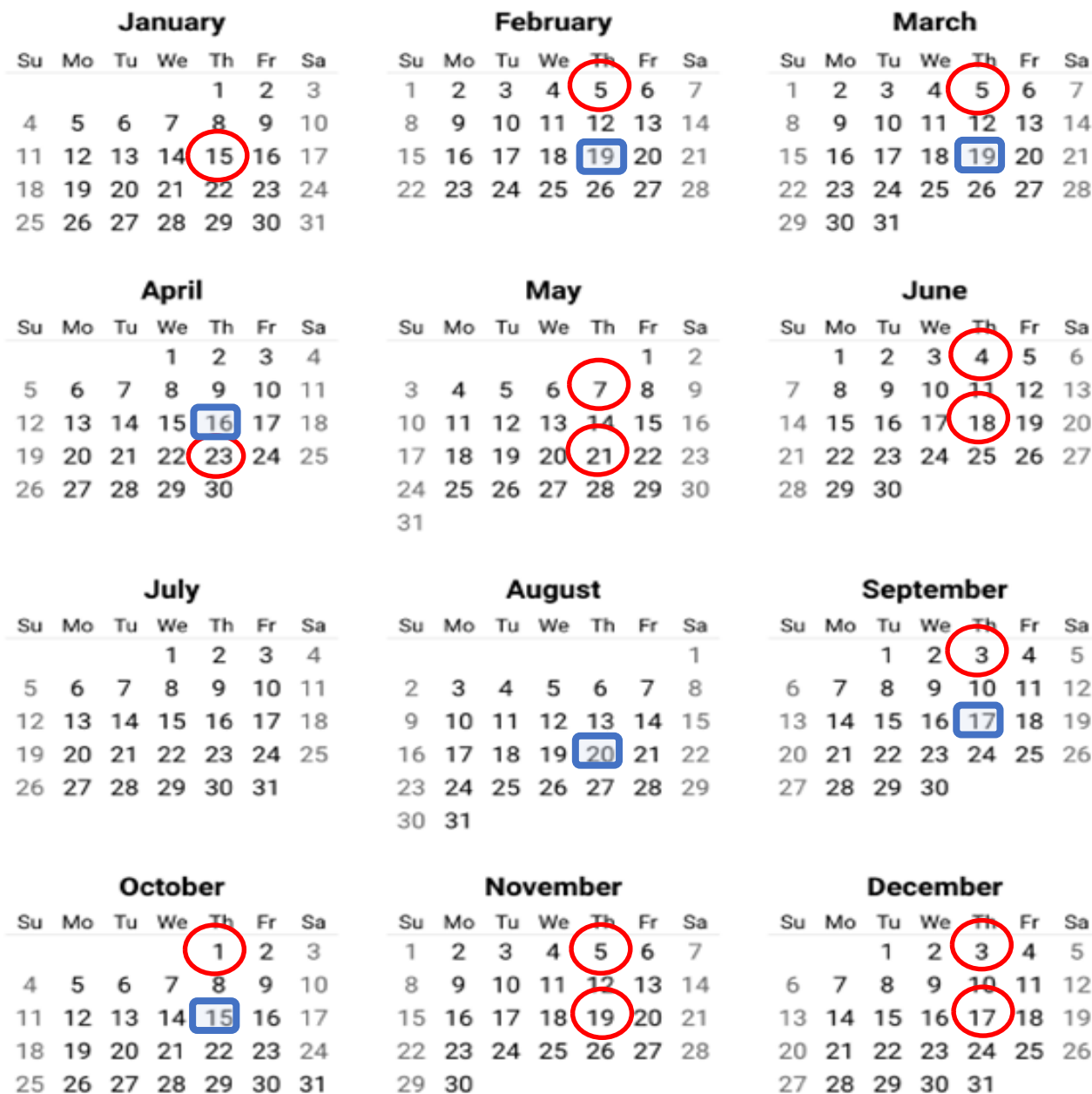
- intersection and corridor improvements, particularly on the Greensboro St and Hillsborough Rd corridors identified by Council Member Merrill and Eversole-Robinson, making use of repaving schedules for improvements, and pedestrian/crosswalk signalization. Keefe suggested breaking the discussion into separate areas, with the following schedule: 2/19 meeting: Greensboro and Hillsborough corridors; 3/5: Bike/Trail Safety (lighting, call boxes, clear lanes); 3/19: Downtown Safety (Slow Zone, Weaver St., 20mph statutory speed limit, signals).
- c. **TMGAC Vacancies/Recommendations** – Eversole-Robinson reminded the Board of town advisory board quorum requirements and as there are multiple vacancies on both the TMGAC and SRTS boards, asked Board members to contact eligible people that they feel would be a good fit for the boards.

5. Adjournment

Chair Keefe adjourned the meeting at 9:04pm.
