- I. **Call to Order:** Dave Mabe called the meeting to order at 7:10 PM.
- a. Minutes. Kirschner motioned to approve the February 11<sup>th</sup> meeting minutes; Hileman seconded the motion. Members voted unanimously to approve the February 11, 2019 meeting minutes.

- II. **Report on Comprehensive Bicycle Transportation Plan update steering committee meeting:** Greenways Commission members discussed current ridership levels and taking regular counts to assess ridership.

- III. **Small projects creating connections:** Greenways Commission members discussed how to address projects that are not currently being considered for funding, such as the Turtleback crossing. Members also discussed a potential connection from Berryhill to Weatherhill, the Tanyard Branch-Estes Park Connection, and the use of the Strava Metro feature for planning purposes.
